1. Chair Christopher Malayter called the meeting to order at 1605h UTC.

2. Welcome & Thanks – Christopher Malayter

Christopher welcomed and thanked everyone for attending the meeting.

3. Approval of Meeting Minutes

It was moved by Aaron Hughes, and seconded by Arnold Nipper that the minutes of the April 18th, 2024 Annual Member Meeting be adopted as written. The motion carried with no objections.

4. Financial Update - Shawna Bong

Shawna Bong, as Secretary/Treasurer, provided an update:

Finances were posted in January. Sponsorships are going well and we welcome more.

Shawna was elected Secretary/Treasurer June 2024.

Additional details to match data included in previous years, is provided below.

The bank accounts are reconciled monthly and the annual tax-exempt return will be filed in May, as is normal. Previous filings are at the following location, along with financial reports:

In 2024, sponsors contributed about \$309,000, up from about \$280,000 in 2023.

In 2024 PeeringDB spent about \$65,000 on Software Development and Maintenance, which was up from about \$62,000 in 2023. Product Management was \$54,000 in 2024 and is expected to be \$54,000 in 2025. Cloud services for the hosting and database was about \$32,000 in 2024. Shawna Bong and Chris Caputo's combined services as Secretary/Treasurer, fundraiser, and election facilitator amounted to almost \$71,000 in 2024.

PeeringDB currently has about \$475,000 in the bank.

6. Operations Committee Update - Job Snijders

Job Snijders, as chair of the Operations Committee, provided an update:

The whois (port 43) service was discontinued in 2024. PeeringDB has a TLS-protected API for this function.

MFA options were rolled out. Users have multiple choices to protect their accounts. MFA will become mandatory later this year. Announcements will be coming.

PeeringDB has deployed multiple rate limiting mechanisms. These have been working well overall although in the last year there were a couple instances where this did not work as well. This is being looked into and addressed for the future.

The committee is working to get additional resources to help with system administration tasks in order to make more progress.

Job asked for questions and comments:

Arnold Nipper brought up an issue with responsiveness during 0000h UTC. Job will look into this further and Arnold will provide more

information. Currently UptimeRobot monitors this but more information will be needed to pinpoint the issue.

Chris Caputo added that the slow down may be due to increased users during that time. The issue will be monitored.
